The Federal Bar Association, Maryland Chapter, is pleased to offer once again its popular Introduction to the Federal Courthouse Program for new members of the Maryland Bar. And, as in the past, the program will be followed by a Gourmet Reception.

This program is designed to acquaint new lawyers with the operation and function of the various agencies associated with the Federal Courts. Speakers will include judges and magistrate judges of the United States District Court, the United States Bankruptcy Court, and representatives from the United States District Court Clerk's Office, the United States Probation Office, the Federal Public Defender's Office, the United States Attorney's Office, the United States Trustee's Office and an experienced civil litigator.

The program will conclude with a Special Admissions Ceremony for all those who wish to be admitted to practice before the United States District Court for the District of Maryland. The combined Introduction to the Federal Courthouse Program and Special Admissions Ceremony is held only once each year and is the only program which permits candidates for admission to the District Court to be sworn-in without the necessity of having their sponsors appear.

Important: A sponsor is still required, but need not appear with you. See Local Rule 701.
