Scope

The United States District Court for the District of Maryland is pursuing commercial off-theshelf software to replace our existing fifteen year old locally developed court calendar, consolidate numerous multi-user Lotus Notes calendars and automate the request, assignment and tracking of facilities, resources and services. In order to reduce the cost of implementation and utilize current IT staff expertise the software must integrate with the court's existing IT infrastructure. Since the administration software portion will be limited in the number of users it can be local installed client application based, with Active Directory integration. However, due to the large number of users the calendar and booking components must be web-accessible with Active Directory integration. The software must provide the flexibility for subsets of the data to be used on public facing websites, public kiosks in multiple courthouses, and customized web browser-based and printable reports. Due to the sensitive nature of a portion of the data, as well as, the general security policies of the federal judiciary the software must run locally and the central data repository maintained within the federal judiciary's secure data communications network. Initially the software must support 250 users in three main courthouses and a half dozen off-site locations, with at least 50 concurrent users. As the district migrates towards shared administrative services the system will need to be scalable to accommodate future potential inclusion of the Bankruptcy Court and Probation Office totaling approximately 850 users.

Feature Requirements

- Clean, easy-to-use interface with adjustable font size, styles, and colors
- Standard format calendar display in traditional day, week, month, and list layouts
- Authentication integration with Microsoft Active Directory
- Automated population of user accounts based on Active Directory object creation
- Customizable calendars based on group membership
- Customizable calendar views based on event type, location, or resources
- Schedule rooms and resources located in multiple locations from one system
- Ability to easily link multiple venues and resources to a single reservation (overflow rooms, remote VTC resources, etc.)
- Support for complex recurring events and changes such as "cancel Tuesday from date x to date y"

- Support for federal holidays, local court scheduled closings, weekends and emergency inclement weather closing
- Drag and drop scheduling
- Ability to create resources that include persons, services, and technology
- Ability to track resource preparation through configurable status changes
- Ability to submit reservation requests that are automatically approved based on room availability, as well as, ability to submit reservation request that require administrative approval
- Ability to notify multiple users via email of request for resources
- Ability to send reminder notifications for resource requests
- Ability to change reservation location without having to change resource requests
- Ability to customize booking interface for specific court events (Bench trail, Jury trial, Investiture, etc.)
- Customizable security to limit access to types of bookings, scheduled events as well as individual data fields within
- System notification when attempting to assign location that does not meet the required resource request
- Ability to deliver iCal feeds
- Ability to import and export calendar/scheduling data using industry standard data exchanges such as XML, API, RSS, SSIS, etc.
- 50 simultaneous web sessions
- Minimum of 10 concurrent individual client access licenses for administrative tasks (room scheduling, resource management, etc.)
- Ability to create at least 5 base calendars (Baltimore Court, Greenbelt Court, Administrative Events, etc.)

Support Requirements

- Annual maintenance agreement which includes software upgrades and patches and unlimited technical support instances.
- Consultation for design creation, initial setup, configuration and all required data interfaces including loading current calendar table that provides views for existing intranet, internet and kiosk
- Onsite training for administrators and end-users
