STANDING ORDER 2015-01


Multiple petitioners in this district have filed 28 U.S.C. § 2255 motions challenging their career offender sentences under *United States v. Descamps*, 133 S. Ct. 2276 (2013).

Specifically, in these cases, petitioners are arguing that under *Descamps*, one or more of the prior convictions that originally qualified them as career offenders under U.S.S.G. § 4B1.1 are no longer career offender predicates, and thus, they are now serving unlawful sentences.

This Court now orders that the briefing schedule in all of these cases is suspended, and these cases will be held in abeyance pending the United States Court of Appeals for the Fourth Circuit's decision in *United States v. Foote*, No. 13-7841. In that case, at issue is whether a challenge to an advisory career offender sentence based on intervening case law is a cognizable claim under 28 U.S.C. § 2255. The Fourth Circuit's decision in *Foote* is likely to inform the outcome in the pending Section 2255 motions challenging career offender sentences under *Descamps*. Therefore, this Court issues this Order for purposes of judicial efficiency

Within 30 days after the Fourth Circuit decides *Foote*, the parties must give the Chief Judge a status update on the pending Section 2255 cases referred to in this Order.
