

## CM/ECF Validation inside CJA eVoucher

CJA eVoucher has the option of a read-only connection with the District's CM/ECF database. If your court has turned on that option, you can enter your login and password into your profile and be able to search for basic case information and a modified version of the docket report for a case.

To validate your CM/ECF login and password in eVoucher, go to your profile by clicking the Profile link on your home page or select My Profile under the Help menu.

Click the Edit button to the right of the Login Info section in My Profile.
