After answering, the Garnishee may pay any garnished indebtedness into court and may deliver to the U.S. Marshal any garnished property, which shall then be treated as if levied upon by the U.S. Marshal. TO THE DEFENDANT/JUDGMENT DEBTOR:

You are hereby notified that **federal and state exemptions may be available** to you.
